#### **Risks involved and minimising those risks**

- Moving the SLR is heavy and takes place adjacent to the highway. Volunteers must therefore work in pairs and should wear florescent jackets (provided by Twyford PC) when undertaking this work.
- Foard Maintenance are experienced in moving and installing the SLR, and will oversee the movement. If volunteers are involved, they will receive training from Foard Maintenance.

## **Twyford Parish Council.**

- Anyone responsible for moving the SLR should be aware of manual handling procedures
- The foot of the step ladder should be away from the edge of the Highway, and be held by a second person.
- Unnecessary risks are not to be taken
- The unit shall only be transferred during daylight hours
- The battery to the until will be charged in the cupboard in the pavilion where ventilation has been assessed
- The battery and unit will be inspected at each movement
- The data download will be done by a volunteer at the side of the roadside. Any damage to personal laptop will be at the volunteer own risk.
- Weather conditions will be assessed at each movement, and if the weather adds a risk to the installation (for example, high winds) the installation will not take place

### Other things which can be done to minimise risk

- The Parish Council will receive regular reports from the group of volunteers about any
- potential dangers experienced by the volunteers and will aim to minimise those risks.
