#### 134/23 Planning Applications

No objection. The Council supports the proposed plans and welcomes the quality of the documentation submitted with the application. A sensitive approach must be taken towards deliveries and other construction related traffic due to the location of the site.

#### SDNP/23/04799/LDE

Woodland Drove, Park Farm Main Road Twyford Moors Hampshire SO21 1EX

Council does not dispute the evidence submitted in support of the application. However, it would like the permission to be granted for a specific use, which is that of occupation only by a gamekeeper employed by the estate on which the site is located.

The Council queries whether the application for CIL exemption is correct since the permission is to regularise use of the caravan and in doing so formally creates permanent permission for a dwelling.

#### 135/23 Recreation Committee

The draft minutes of the meeting of the Recreation Committee held on 15<sup>th</sup> November 2023 were received.

There were no recommendations. Cllr. Pullen highlighted the work that was being planned for the 60<sup>th</sup> anniversary of Hunter Park next year.

## 142/23 Tree Planting at Berry Meadow

Cllr. Corcoran introduced a report, which is attached in the appendices, regarding the planting of trees in Berry Meadow. Members asked for clarification on several matters regarding distance from the boundary and potential effect on views and impact on streetlights. Professional advice on the planting had been sought from a consultant and a report provided.

It was Resolved to approve the planting of 30 trees in Berry Meadow, of which 15 would be in an avenue and 15 in a cluster. The species will be a mixture of Beech, Lime, Elm and Alder. The avenue of trees will be planted between 3.5 and 4.5 metres from the boundary fence and spaced 12 metres apart.

The Clerk will sign the Memorandum of Understanding with the South Downs National Park Trust and also apply for small grant from Winchester City Council to cover the remaining costs of the work.

## 143/23 Hazeley Road Development Area Advisory Committee

Cllr. Corcoran gave a verbal update and advised that he had written to Cllr. Jerry Pett at WCC, who is WCC's appointee to the SDNPA, regarding the coordination of the multiple projects and planning applications. A positive response had been received a meeting was to take place very soon.

Cllr. Lawton advised that the housing site applicant has confirmed that they are now in dialogue with the SDNPA regarding the layout of the site and this may result in changes being made to the application.

# 144/23 Traffic Solutions Advisory Committee

Cllr. Hoad advised a meeting of the committee was due to take place in January. He had previously reported progress on Finches Lane informal crossing and Hazeley Road gateways and these were still on schedule.

Cllr. Cook reported that both Cllr. Greenberg and herself had made representation to the M3 Junction 3 hearing and also highlighted that a recent closure of J11 has caused some issues for diverted traffic which she had reported to HCC highways.

# 145/23 Climate Advisory Committee

Cllr. Forder-Stent advised that climate training was taking place next Thursday, and the group was always looking for new members. She also highlighted steps that were being taken to monitor groundwater levels which high for this time of year. Cllr. Corcoran indicated that the ditch in the field adjacent to Finches Lane will need clearing to assist in preventing flooding.

The Clerk advised that he will add an agenda item on Flooding to the next meeting of the Council.

# Proposed Tree planting of Avenue and Clump on Berry Meadow Report by Cllr. Chris Corcoran

At the October meeting of Council I was asked to bring together the

- 1. Landscape architect's report
- 2. My conclusions
- 3. Any comments from Councillors or from the Farm Committee members
- 4. Updated costs
- 5. Update on the planting programme

#### 1. The landscape architects report

You will see that the report covers both the clump and the Avenue; it advises on the location, species and spacings for both, with advice on the pruning of the self-sown trees on the fence line. It endorses TPC's "gateway" concept with the Avenue complementing the parkland edge of Shawford Park but maintaining clear views to the North across Berry Meadow. The location of the avenue trees is a key issue The advice is that ideally, they should be as close as possible to the Shawford road i.e., to the fence but following the line of the fence.

However, the report notes that TPC should be aware of the possible impact of tree roots on the SW pipes in the Highway verge and that SW require a 6 m setback for large trees. This is where they have wayleaves or where consents are required. In terms of number of trees in the Avenue the spacing recommended of 12 m. This would mean 15 trees; with 14 trees in the clump this total 29 trees , - an increase of 4 on the number to be donated by the South Downs .

As for species, you will see that HED recommends the introduction of disease resistant elm and for a mix of native species.

#### 2. My conclusions

Location of Avenue: I suggest a set back from the fence of 3m; the SW pipe does not have a wholly even curve and does not follow either the line of Shawford Road or of the fence. A 3m setback from the fence is generous overall and tight at the point where the eastern of the two Walnut tree is already established much closer to the SW pipe.

Species and spacing: accept the Advice given with the addition of four extra trees to be disease resistant elm. The mix will be more resistant to disease and reflects the varied species mix in Shawford Park. The spacing recommended for the Avenue allows for the views through to be maintained.

Pruning of Walnuts: accept and refer to the farm Cttee.

#### 3. Comments

Jonathan McGill is the only one to comment. He notes that a strict interpretation of the 6m distance from the SW pipe and the following the line of the fence means a 6m setback from the fence. Also, that a single species for the avenue (beech) is to be preferred. My Response on the 3m vs 6m setback is that in visual terms the Landscape architect clearly recommends a minimum set back. TPC has no obligation to follow SW guidance which for wayleaves and where consents are needed. As I have pointed out, the vigorous well grown walnuts will be 3m closer to DSW pipe than the Avenue trees. However, I would recommend that the distance be increased to 4.0 m so as to give space for a tractor with flail to get between the tree guards (1.6 m) and the fence. As to the mix of species, this is a joint approach of SDNPA and the landscape architect; as noted above, it reflects the varied species in Shawford park. Beech and lime will be predominant in the mix.

#### 4. Updated costs

Timber Rails and posts as first estimated for 25 trees	£1700

Note: I have asked Mole Valley for a quote for the timber to give a more accurate figure.

Provision for meeting these costs is at present as follows:

SDNPA £1,500 Climate Change Budget £850 Reserves £500 Total £2,850

There is a £250 shortfall which needs to be covered. This would be done if WCC agree to a grant. Otherwise, it would be an additional sum from the reserves or an application to Twyford Charity.

Note: All trees, with rabbit guards and stakes, are to be supplied by SDNPA at no cost to TPC. SDNPA have increased the number of trees by 5. These are disease resistant elm to be delivered in the New Year

#### 5. Planting Program

The original 25 SDNPA trees are now available and can be delivered on weeks' notice anytime between now and the end of February. SDNPA have a separate scheme for planting elms and 5 have been allotted to us which neatly makes up the total recommended by the Landscape Architect; these will be available in the New Year .

The strimming can be done at any time and with a tractor as proposed is less than an hour's work . The marking out of the tree positions follows and then the

bashing in of the posts. All this can be done immediately and does not have to wait for the trees.

#### **Recommendations:**

- 1. Proceed as outlined above.
- 2. Approve a virement of £250 from general reserves to the Parish Farm budget

#### Jonathan's Comments:

#### An observation and a view:

The report says the row of trees should be at least 6m from the line of the sewer, and a constant distance from the fence line. As the sewer line 'kisses' the fence line in a couple of places, my understanding is that report proposes that the row of trees should be in a line following the fence line, and at least 6m from the fence.

I note that a mixed row of trees is proposed to offer greater diversity and therefore climate resistance. If the row, or avenue, is to create a gateway to the SDNP and to the village. Personally, I would plant single species to create an aesthetic avenue rather than an irregular avenue of mixed species. I am pretty confident that Capability Brown would have gone single species! I think the beech would be spectacular!

#### **Clerk's Comments**

In order to receive the trees and associated funding, Council needs to sign a Memorandum of Understanding (MoU) with the South Downs National Park Trust. The MoU sets outs the expectations of both parties and is a simple and straightforward agreement. On the Council's part is it expected that it do it's best to ensure the trees are well cared for, will report from time to time back to the SDNPT on progress, and agrees to inclusion in publicity for the park wide planting initiative.
